Recovering England's lost footpaths

Public Footpaths in England

- Many former public rights of way have been lost from the Definitive Maps
 - Each Highway Authority maintains the definitive map and is responsible for public rights of way
- "Once a highway, always a highway"
 - Many paths not recorded when definitive maps created (1950s)
 - Unless 'stopped-up', routes remain in existence and can be added to Definitive Maps

- Countryside & Rights of Way Act 2000
 - Set cut-off date of 1st January 2026
 - Extinguishment provisions not subsequently brought into force
 - As of now, probably will be 2031...
- "Don't Lose Your Way"
 - Ramblers-led action to recover lost paths
 - 49,000+ miles of lost paths identified
 - Volunteers across English HA areas to research and raise DMMOs

Bridleways? British Horse Society – aligned actions... Rest of the UK? Wales, similar; Scotland & NI, different...

Public Footpaths in Derbyshire

- Around 2200 lost paths
- 165 high priority
- 190 medium priority
- 421 low priority
- 192 in process


... and the rest 'invalid' for various reasons

Derby City – separate Highway Authority – only 79 paths in total









- DLYW map is accessible to everyone
- The aim is to get local knowledge to best prioritise the lost paths
- Our focus is to add to the definitive map the most practical paths with the greatest community benefit
















Public Footpaths in Derbyshire

- 1. Prioritise the identified paths (and add any others)
- 2. Research high priority paths evidence of existence, not of use
 - NPAC Act 1949 Parish Claim maps and schedules
 - Old OS maps
 - Finance Act 1910 maps
 - Tithe Act 1836 maps
 - Inclosure [enclosure] Acts 1801, 1845 maps
 - Stopping-up Orders
 - Relationship to other routes (Moser v Ambleside UDC 1925 precedent)
 - Evidence of public expenditure
- 3. Identify landowners
- 4. Submit DMMO to Highway Authority
